## Energy Storage: Status and Potential

## Electric Vehicle Infrastructure Coordination and Utility Investment in the Midwest

## A Field Update on Commercial PACE Programs

This presentation will provide an update on Wisconsin's Commercial PACE program, which has expanded to 34 counties. PACE Wisconsin was established in 2016 when a group of Wisconsin governments and NGOs, including the Wisconsin State Energy Office, developed a uniform program that any county can join by passing a resolution adopting it. The presentation covers recent Wisconsin projects financed in part by PACE, the results of free energy audits in Milwaukee funded by the DOE's Better Buildings Program, and suggested topics for further policy study to facilitate more participation in the program.

## Energy Security Planning Roundtable: A Comparison and Contrast of State Plans

To start this facilitated discussion, two Midwest states, Michigan and Wisconsin, will offer brief insights into their approaches to energy security planning. Each state will then highlight relevant portions of their energy emergency plans and contrast their plans with border states. The session will also provide an update on recent energy emergency exercises in the Midwest region, with special emphasis placed on cybersecurity, propane stocks, and petroleum shortage contingency plans.

## Petroleum shortage contingency plans:

- 1. Have you dealt with a petroleum shortage and how did your office respond?
- 2. What written contingency plans do you have to deal with petroleum shortages? Do you include the private sector in your planning efforts?
- 3. Do you track state, regional, and national crude oil prices and petroleum products' wholesale and retail prices?
- 4. Do you participate in the State Heating Oil and Propane (SHOP) program? How do you use this program to monitor supply and distributor levels?
- 5. What supply management or demand restraint actions might you take during a shortage? How would you communicate these actions?

## Cybersecurity and response plans:

- 1. Does your state have a cyber response plan, and if so, who is the responsible agency? Are private entities involved in this planning as well?
- 2. If a cyber attack caused a natural gas or petroleum shortage, or a power outage, how would the response be different from any other event that might have caused the same shortages?
- 3. What actions are occurring in your state that will help to reduce the threat of a cyber attack on the energy sector? Are you offering training for local governments?

## **Opportunities and Challenges: Disaster Recovery Reform Act of 2018**

On October 25, 2018, the Disaster Recovery Reform Act of 2018 (DRRA) was signed into law as part of the Federal Aviation Administration Reauthorization Act of 2018. DRRA includes historic changes to the *Stafford Act* which could impact the efforts of state and local governments to integrate energy resilience into pre- and post-disaster infrastructure investments. This session will focus on the DRRA's impact on states in the Midwest Region and will highlight which of its fifty provisions directly apply to State Energy Offices. The session will also provide information on the specific amendments to the *Stafford Act* as a result of this legislation.

## Meeting the Energy Needs of Agriculture and Rural Communities
