A "Dear Colleague" letter is being circulated on a bi-partisan basis in the House of Representatives by Rep. McKinley (R-WV) and Rep. Tonko (D-NY). The letter is seeking \$70 million for the State Energy Program (SEP) and \$230 million for the Weatherization Assistance Program (WAP) for FY'18 federal appropriations.

Governor Andrew Cuomo recently launched a major electric vehicle (EV) rebate and outreach initiative to encourage the adoption of clean cars in New York. NYSERDA will manage the program, and will provide rebates of up to \$2,000 for purchase of a new EV or hydrogen fuel cell car.
