North Carolina is developing a \$600 million commerical-scale wind farm project by Iberdrola Renewables, LLC, which will put 102 turbines on 22,000 acres near the coastal community of Elizabeth City. Once completed, it could generate about 204 megawatts, or enough electricity to power 60,000 homes. Learn More

The Tennessee Department of Environment and Conservation is offering rebates for qualifying electric vehicles that are purchased, or leased and registered in the state.
