

# Congressman Tonko Reintroduces SEP and WAP Reauthorization in the House

The bill reauthorizes the Weatherization Assistance Program at \$450 million per year for FY2016 through FY2020 and the State Energy Program at \$75 million per year for FY2016 through FY2020. 
### Governor Haslam's EmPower TN Initiative Set to Cut Tennessee Utility Bills by an Estimated 28%
