Iowa Releases RFP to Develop an Energy Storage Assessment for the State

The Iowa Economic Development Authority and Iowa Energy Office are initiating an energy storage assessment that will perform a review of related energy and economic development opportunities in Iowa. The assessment will also analyze state-specific data including battery supply chain, potential storage users, policies, regulations and the utility landscape.



Utah's International Partnerships Push Energy Forward

In the past few months, Utah's Governor's Office of Energy Development (OED) has solidified key international partnerships with Canada, Mexico, India and Japan that will further energy collaboration across policy, development, education and innovation for years to come.

Virginia's Biggest Renewables Contract to Date

Virginia now has the most substantial renewable energy contract in the United



States at 420 megawatts, thanks to a recent decision by Governor Ralph
Northam. According to Utility Dive, the contract draws from solar and wind, leading to energy production that meets 45% of Virginia's yearly energy demand.



USDA Announces Loan Program to Support Rural Electrification

On November 1, 2019, the U.S. Department of Agriculture (USDA) announced investments of \$1.4 billion to build and improve rural electric infrastructure in 21 states, with funding to be provided through the Electric Loan Program, which offers insured loans or loan guarantees to support the construction or maintenance of rural electric infrastructure.
